

## NCC Alternate Member By-Law #3 Amendments

### 5. **NCC MEMBERSHIP** *(Clause 5 of By-Law #3 to be amended as shown in bold italics)*

NCC Membership consists of:

- owners of Corvettes and are referred to as a Member;
- individuals who are Corvette enthusiasts and are interested in the NCC but do not own a Corvette, and are referred to as an Associate Member;
- an individual who is a part of the immediate family of a Member or Associate Member, such as a spouse, significant other, or child, and are referred to as an Affiliate Member. Each paid membership may include one Affiliate Member.

An Honorary Membership in the NCC may be extended to Members having shown exemplary service and is nominated by a Member of the NCC. Nomination approvals shall be determined by the NCC Executive and designated by resolution.

***An Alternate Membership in the NCC may be extended to any person who is not currently a NCC Member. An Alternate Membership may only be requested by a Primary Member (a Member or an Associate Member). Alternate Membership status enables this designated person to participate in a NCC sanctioned, non-subsidized, event or activity as a substitute for the Affiliate Member or the Primary Member.***

***A fee shall be administered for the establishment of an Alternate Membership. The current fee shall be in the document entitled "NCC Operating Policy" as set out in Schedule "B".***

***Alternate Membership status is automatically revoked at the end of the calendar year for which the Alternate Membership was approved.***

***Guidelines and considerations pertaining to an Alternate Membership are provided in the document entitled "NCC Operating Policy" as set out in Schedule "B".***

Persons noted ***within the Membership classifications*** above are considered as a Member of the NCC.

### 12) **Attendance at NCC Meetings, Events and Activities** *(Section 12 of Schedule B to be amended as shown in bold italics and strikethrough)*

Attendance at NCC meetings, events and activities is limited to NCC Members, ~~only (Members, Associate Members, Affiliate Members and Honorary Members).~~

~~If a Member would like to invite a non-Member to participate in a NCC event or activity (e.g. children, person to serve as a navigator for a NCC cruise), an approval to do so needs to be obtained from a member of the NCC Executive.~~

A person interested in becoming a Member of the NCC may attend one (1) meeting with the approval of a member of the NCC Executive, to determine if they would like to become a Member. Once they have attended a meeting, they may not attend another meeting without becoming a Member first. Potential members will not be allowed to attend the Annual General Meeting (AGM) of the NCC.

***If a Primary Member (a Member or an Associate Member) would like a non-Member to participate in a NCC sanctioned, non-subsidized, event or activity, an Alternate Membership for the non-Member must be requested by the Primary Member. Alternate Membership status enables this designated person to participate in a NCC sanctioned, non-subsidized, event or activity as a substitute for the Affiliate Member or the Primary Member. The Alternate Member must be registered at least seven (7) days in advance of the NCC sanctioned, non-subsidized, event or activity.***

Occasionally NCC will hold open events (e.g. NCC Car Show, NCC Family Picnic/BBQ) that may be attended by non-Members. ***"Open House Quarterly Membership Meetings" (typically March, June and September) may be established at the discretion of the Executive. "Open House Quarterly Membership Meetings" would allow for a family member or somebody else to attend a NCC Meeting to get firsthand experience with the NCC, perhaps then joining the NCC if they are interested.***

## NCC Alternate Member By-Law #3 Amendments

If a Member is uncertain about the involvement of a non-Member in NCC meetings, events and activities, the matter should have prior clarification discussion **and approval** with a member of the NCC Executive.

### **13) Alternate Memberships (Section 13 to be added to Schedule B)**

***This class of Membership is being created to allow NCC Members to share their hobby with family members or friends, and to allow a substitute to be designated when the Primary (a Member or an Associate Member) or Affiliate Member is unable to participate in a NCC sanctioned, non-subsidized, event or activity. A subsidized event or activity is a NCC sanctioned event or activity that has some or all of the associated costs paid for by the NCC.***

***If a Primary Member would like a non-Member to participate in a NCC sanctioned, non-subsidized, event or activity, an Alternate Membership for the non-Member must be requested by the Primary Member. Alternate Membership status enables this designated person to participate in the NCC sanctioned, non-subsidized, event or activity as a ride along substitute for the Affiliate Member or the Primary Member (e.g. a person to serve as a navigator for a NCC cruise). The Alternate Member can only participate in a NCC sanctioned, non-subsidized, event or activity as a substitute and cannot attend as an additional third party. The Alternate Member must be registered at least seven (7) days in advance of the NCC sanctioned, non-subsidized event or activity. This will qualify the registrant as a Member of NCC and entitles the registrant to the full insurance protection of NCC's Liability Insurance Policy.***

***The following restrictions and conditions also apply to an Alternate Member:***

- i) The Alternate Member must be 16 years of age at time of registration.***
- ii) The Alternate Member is not restricted to only related family members but can be a neighbour or friend.***
- iii) The Alternate Member does not have voting rights within the NCC.***
- iv) The Alternate Member may be invited to attend one or more of the NCC Meetings designated as "Open House Quarterly Membership Meetings".***
- v) The Primary Member can register a maximum of three (3) Alternate Members per calendar year, at a membership fee of \$10.00 each. Application for registration is to be completed by submitting the NCC Alternate Member Application Form found on the NCC Website along with the membership fee. A registered Alternate Member cannot be changed or refunded during the year. The membership fee of an Alternate Member may be changed from time to time by the NCC Executive, as deemed appropriate by the NCC Executive.***
- vi) Only one (1) Alternate Member can attend a NCC sanctioned, non-subsidized, event or activity as a substitute for the Primary or Affiliate Member.***
- vii) The Alternate Member can only participate in a NCC sanctioned, non-subsidized, event or activity in the vehicle of the Primary or Affiliate Member, along with either the Primary or Affiliate Member, and not in their own vehicle.***
- viii) The participation by an Alternate Member in a NCC sanctioned, non-subsidized, event should be identified to the NCC at least seven (7) days in advance of the NCC sanctioned, non-subsidized, event or activity, typically through the registration form used for the NCC sanctioned, non-subsidized, event or activity.***

***Alternate Members who wish to participate fully in all NCC events or activities are encouraged to upgrade their membership to a Primary Member with the payment of the differential membership fee amount.***

***The NCC Executive will not tolerate any suspected abuse of this policy.***
